Description

The Faculty Research Award recognizes faculty who have demonstrated excellence in research.

Number of awards and award amount

There will be up to eight \$1,000 awards per year.

Who is eligible to be nominated?

All tenured and tenure-track faculty may be nominated **EXCEPT**:

- Curators' Professors
- Curators' Teaching Professors
- Named Professors
- Department Chairs
- Full-time Administrators
- Recipients of the Missouri S&T Faculty Research Award from the previous year

Who may nominate?

Candidates may be nominated by faculty, administrators, staff or students. Nominations from department chairs are encouraged.

Selection committee

3 Curators' Professors (3-year staggered terms)
1 named professor
3 awardees from the previous year

Timeline for awards

- Call for nominations: June
- Nominee name: August 3rd submitted via Google form <https://forms.gle/4Gb2ePbXgopxyTf3A>
- Nomination deadline for full packet: Sept. 18, 2020 for entire packet submitted via Google form <https://forms.gle/WKy4HarUfemHY9Mq9>
- Decision by the selection committee: October
- Awardees notified by: Nov.9, 2020

The award will be presented to the successful candidates at the annual Faculty Awards Banquet to be held Dec. 3, 2020.

2020 FACULTY RESEARCH AWARD NOMINATION FORM

The criterion for the Faculty Research Award is excellence in research during the previous two years. In addition, the long-term impact of candidate's research activities may be addressed in the candidate's statement and in the letters of support.

The nomination packet shall include:

1. The information requested on this cover sheet.
2. A letter of support from the nominator. Limit: 2 pages.
3. A statement from the nominee providing additional or clarifying information to strengthen the nomination, citing accomplishments in research, scholarship and creative activities. Limit: 600 words.
4. A CV of 10 pages or less **or** the information that is requested on the following pages.
5. Optional: One additional letter of support. Limit: 2 pages
6. A report from the Office of Sponsored Programs detailing research awards and expenditures for the previous five years (or other time period if previous successful application). This will be provided to the nominee for review prior to submission of the nomination package.

Materials utilizing font size smaller than 10 point will not be accepted.



Only activities and accomplishments occurring in the period between July 1, 2018, and June 30, 2020, may be listed as part of the application. No accomplishments or activities included in a previous successful application may be repeated in this application.

1. List peer-reviewed publications, invited journal articles, books and book chapters authored or edited by candidate. List only work published in the time period and list the date of publication in the reference. List title, location, and audience (type and approximate size) of performances, productions and other creative activities. Patents that have been granted within the designated period should also be listed below.

2. List national and international recognition (such as research awards, best paper awards, fellowships, prestigious presentations).

A large, empty rectangular box with a thin black border, intended for the user to list national and international recognition such as research awards, best paper awards, fellowships, and prestigious presentations.
